- 3. Accordingly, the said trust is hereby registered in the register meant for applications in Form No.10A vide F.No.DIT(E)/HYD/12A/24(2)/09-10. This registration is granted with effect from 04.02.2010.
- 4. This registration is subject to the fulfillment of the conditions laid down u/s.12A (a) of the I.T. Act, 1961.
- 5. The registration does not ipso facto exempt the income unless the provisions of Sections 11, 12 and 13 of the I.T. Act, 1961 are adhered to.
- 6. This registration may be cancelled in terms of the provisions of Section 12AA(3) if at any stage it is found that the activities of the applicant trust/institution are not genuine or are not being carried out in accordance with the objects of the trust/institution.
- 7. The applicant shall comply with the provisions of Section 139(4A).
- 8. Any amendment to the Trust Deed/Memorandum of Association would be effected with the prior approval of the undersigned, failing which the registration granted as above will be liable to be withdrawn.
